**Texas School for the Deaf**  
**Release of Liability and Assumption of Risk Agreement**

**All triathletes and/or parents must read and sign. Please read carefully before signing.**

In consideration of registering to participate in the Ranger Triathlon sponsored by the Texas School for the Deaf that will be taking place at the Texas School for the Deaf 1102 South Congress Ave. Austin, Texas I \_\_\_\_\_, (print name) (the "Participant") acknowledge, appreciate and agree that:

1. I acknowledge that a triathlon is an extreme test of a person's physical and mental limits. I hereby certify that I'm capable of completing all three segments, that I'm physically fit and that I've sufficiently trained for this event. I also hereby authorize medical treatment for any and all injuries sustained during this event.
2. Participation in the Ranger Triathlon includes the risk of bodily injury and property damage. Such risk of bodily injury, including serious injury, paralysis or death, from the activities involved during participation is significant. Particular rules, equipment and personal discipline may reduce, but not eliminate the risk. **PARTIPANT AGREES THAT A ANSI OR SNELL APPROVED HELMET WILL BE WORN AT ALL TIMES;** and
3. **PARTICIPANT KNOWINGLY AND FREELY ASSUMES ALL SUCH RISK OF BODILY INJURY OR PROPERTY DAMAGE, BOTH KNOWN AND UNKNOWN, WHETHER SUCH RISK ARISES FROM THE NEGLIGENCE OF PARTICIPANT OR OTHERS, INCLUDING TEXAS SCHOOL FOR THE DEAF, AND PARTICIPANT ASSUMES FULL RESPONSIBILITY FOR PARTICIPATION IN ANY ACTIVITIES IN THE RANGER TRIATHLON. PARTICIPANT, FOR MYSELF AND ON BEHALF OF PARTICIPANT'S HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN, HEREBY RELEASE AND HOLD HARMLESS THE TEXAS SCHOOL FOR THE DEAF, ITS AGENTS AND/OR EMPLOYEES, VOLUNTEERS AND ENTITIES SPONSORING OR CONTRIBUTING TO THE EVENT AND OTHER PARTICIPANTS, WITH REPSECT TO ANY AND ALL BODILY INJURIES, DISABILITIES, OR DEATH, OR LOSS OR DAMAGE TO PROPERTY, WHETHER ARISING FORM THE NEGLIGENCE OF THE CITY OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW;** and
4. Participant willingly agrees to comply wit all USA Triathlon stated or other stated customary terms, rules and conditions for participation; and
5. If Participant observes any unusual or significant hazards during Participant's presence or participation in activities during the Ranger Triathlon, participant will bring such hazard or hazards to the attention of the Race Directors immediately by contacting an employee or representative.
6. Participants willing give their consent for any photographs or media taken during the Ranger Triathlon.

This is to certify that (because Participant is under the age of eighteen), I, (as Participant's parent/legal guardian), have read the foregoing Release of Liability and Assumption of Risk Agreement, fully understand its terms, understand that I and Participant will give up substantial rights by my signing it and do consent and agree to the Release as provided above. I further agree, for Participant, Participant's heirs, assigns, and next of kin, to release and hold harmless all parties, including Texas School for the Deaf, its agents, employees, volunteers and entities sponsoring or contributing to the event from any and all liabilities incident to Participant's involvement in any and all activities with this program. **EVEN IF SUCH LIABILITY ARISES FROM THE NEGLIGENCE OF TEXAS SCHOOL FOR THE DEAF,** to the fullest extent permitted by law.
